Jefferson County



Maria, Adult participant, enrolled in February of 2017. Through the enrollment process it was discovered her math and reading scores needed remediation. She was referred to Community Action for their Adult Education classes. With her previous experience in child care she wanted to find a position locally working with children. A work experience was arranged with Jefferson/Clarion Head Start. Her supervisor has expressed how well Maria is doing with the children and encouraged her to apply for a substitute aid position for when the work experience is complete. Head Start requires all employees to have a driver's license. Goodwill's Driver Education program was arranged through supportive services.

Clearfield County at DuBois



Christopher, of Frenchville, came to PA CareerLink due to him being laid off from his employer. He was encouraged by his employer to obtain his CDL license and in return he would be more valuable to a company. Christopher applied himself and attended workshops and with our assistance he was able to attend CCCTC to obtain his CDL Basic A license. He was rehired after successfully obtaining his CDL at Austin Powder. He is currently working full time with the promise of the increase in pay. He continues to keep in touch during his follow up period. Christopher stated he is thankful for all of our help.

Jennifer had office management skills as well as an Associate Degree in Business Administration. 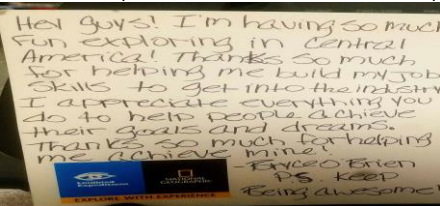
Cameron County
