Highlights for this quarter –

Carla F, PID 5172719, was a RESEA participant who had worked in HR and business management and had lost her job due to fluctuations in the oil/gas industry. She wanted to remain in business management and was interested in finding a job out of the oil/gas industry. She had previously been a teacher and wanted to find a position where she could return to helping the community. Her resume was reviewed and suggestions were made, and she met with the WIOA dislocated worker program staff. She was referred to several job postings of interest. As of November 4, she was hired as the Executive Director of The Arc of Jefferson & Clearfield Counties, where she manages the business end of a large human service agency working with individuals with disabilities.

Lois D., PID 4197242, was a RESEA participant who attended orientation and PSM on 07/29/2019. She had been employed as a dental assistant with the same office for many years and was very upset to leave. At PSM, her resume and experience were reviewed and she was shown how to navigate the PA CareerLink website to assist in her job seeking efforts. She also attended a Basic Computer Skills workshop at the PA CareerLink on 08/05/2019. As of her 60 day follow up, the participant reported that she had been hired at Punxsy Dental as a Dental Assistant through the PA CareerLink website (job posting 12955961), with a start date of 09/11/2019 and an hourly wage of \$12.50.

Haley M., PID 972919, was a RESEA participant who attended orientation and PSM on 08/27/2019, having been laid off from a large hospital as a medical assistant. She had a master's degree in social work but was not working in that field. She attended the Resume and Cover Letter workshop on 09/09/2019 at the PA CareerLink and afterward her resume was critiqued by staff. At her 30 day follow up, she reported that she had accepted at position as a social worker at Clarion Psychiatric Center with a start date of 10/07/2019 and an annual base salary of \$51,633, which is significantly higher than her previous job.
